SAREX / M.U.S.T.A.N.G. EVENT **June 24-25, 2017** **Airlake Airport, Lakeville MN**

Minnesota Wing Civil Air Patrol (the “CAP”) will be joining with SRRRMN to host a multi-disciplinary joint SAREX (Search and Rescue Exercise) training session in Lakeville, Minnesota.

This training will represent the first time the CAP will pool its expertise and resources to develop operational experience and relationships with other search agencies and resources. The event provides a unique opportunity for diverse members of the search community to work together in an educational and interactive exercise and to build relationships with resources you may not routinely encounter.

Attending search disciplines and resources will include:

- Minnesota Wing Civil Air Patrol
(including its command and communications group, as well as airborne search and ground teams)
- A UAS (Unmanned Aircraft System, i.e. “drones”) service provider
- K-9 teams
- Mounted posse units
- Search management resources
- Other search resources

The weekend schedule is currently planned as follows:

- Saturday, June 24th: Capabilities training session showcasing the different disciplines, with appropriate demonstrations and interaction with the attendees. This will be held at Airlake Airport and based in the CAP operations hanger.
- Sunday, June 25th: Simulated search and rescue operation in the Lakeville, MN area. CAP staff, together with the exercise’s IC team, will direct the multiple units and search resources through a search exercise.

Participants wishing to stay Saturday night will have access to designated areas approved for tenting, RV parking, and an area for mounted units with their horses.

ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

Please read this agreement carefully before signing it. Your signature and date confirms that you have read, understood and fully accept and agree to the terms and conditions. By signing this agreement, you are agreeing among other things to fully accept the risks of participation and are giving up certain rights, including but not limited the right to recover damages, expense reimbursement (particularly medical expenses) and compensation in case of injury, death or property damage arising out of or in connection with your participation in this event.

I, the undersigned, do hereby accept and assume all risks associated with participating in this Event of any kind, including, but not limited to, injuries or death to me or damage of any kind to my property; falls, bites, kicks, contusions from any and all animals participating in this Event; being thrown or bucked off a horse; any allergic reactions; tripping on uneven terrain; damages from or the failure of any materials or equipment; contact with other participants or spectators; the effects of any kind from the weather, including but not limited to heat or high humidity, rain, tornadoes, thunderstorms, hurricanes, snow, ice, or any other weather event; all vehicular, airborne or pedestrian traffic or instrumentality; any conditions of any road surface, field, forest or path, water condition or surface, or other terrain; and any and all risks associated with participation in the Event, known or unknown.

For myself, my heirs and assigns and anyone entitled to act on my behalf, I hereby waive and release SRRRMN (Search, Rescue and Recovery Resources of Minnesota), and all sponsors of the Event, and their respective representatives and successors, officers, directors and employees from all claims or liabilities of any kind arising out of my participation in this Event whether or not any such claims or liabilities might arise out of negligence or carelessness, or any willful or non-willful act on the part of SRRRMN or the sponsors or their respective officers, directors, or employees, or any other participants in or any observers of the Event. I further agree to indemnify, defend and hold harmless SRRRMN and any of its officers, directors, or employees from any and all risks, liabilities, claims, damages, costs and expenses (including attorneys' fees) incurred by or asserted against SRRRMN or any of its officers, directors or employees, arising in any way from my actions or inactions, negligence, carelessness, willfulness or otherwise, including the actions or inactions of any animals I might bring to or utilize during the Event.

Further, I hereby consent to and authorize the use and reproduction of any and all photographs and video taken of me or my horse during or relating to the Event for any purpose whatsoever, without further compensation. Such photographs and videos shall be property of the SRRRMN.

ADDITIONAL WAIVER FOR MOUNTED PATROL RIDERS

I am 18 years of age or older and I know that riding a horse involves certain risks and that my participation in the Event may be a potentially hazardous activity. I understand and agree that I and my horse may be exposed to unfamiliar riding conditions and dangers and I should not participate in the Event unless I am confident in my riding abilities and in my horse's ability to remain under my control at all times. I understand I will be required to wear a proper helmet while participating in the Event.
